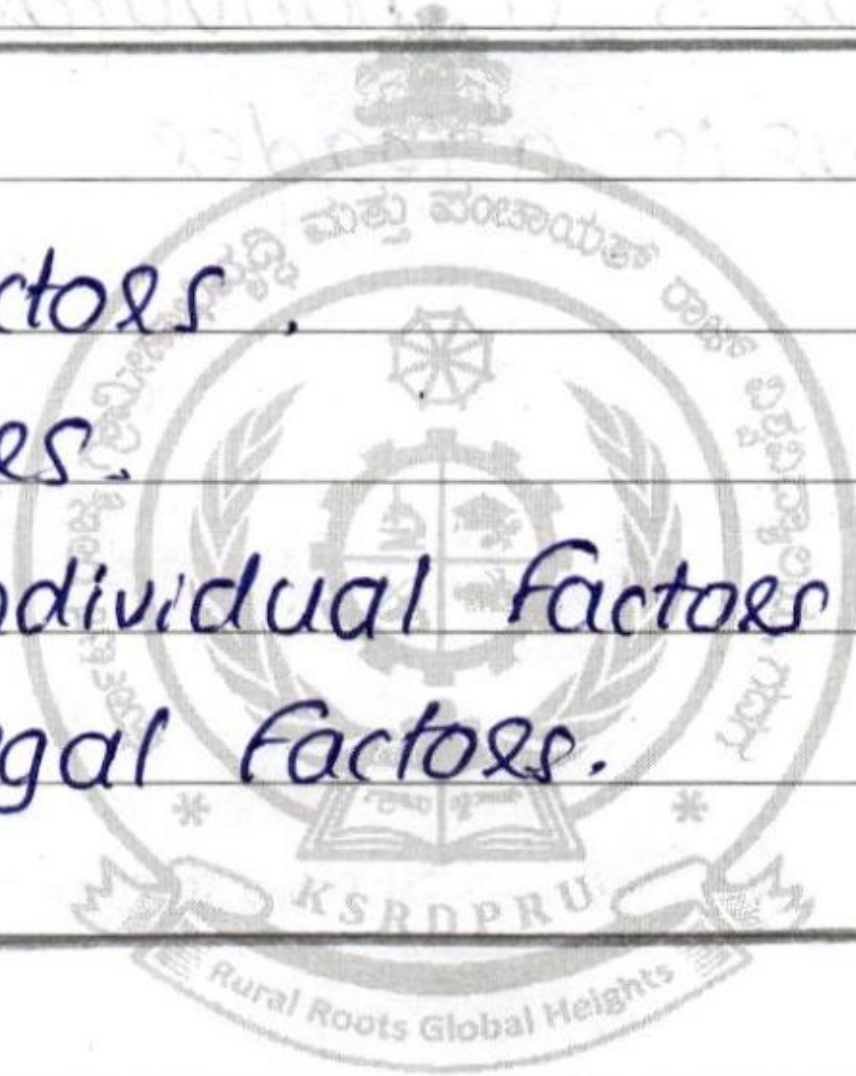

5) Stage - V :- Startups and AI era :- (2021-present)

In fifth stage Startups, AI, Robotics, etc. are introduced. This is present situation where entrepreneurship is developing.

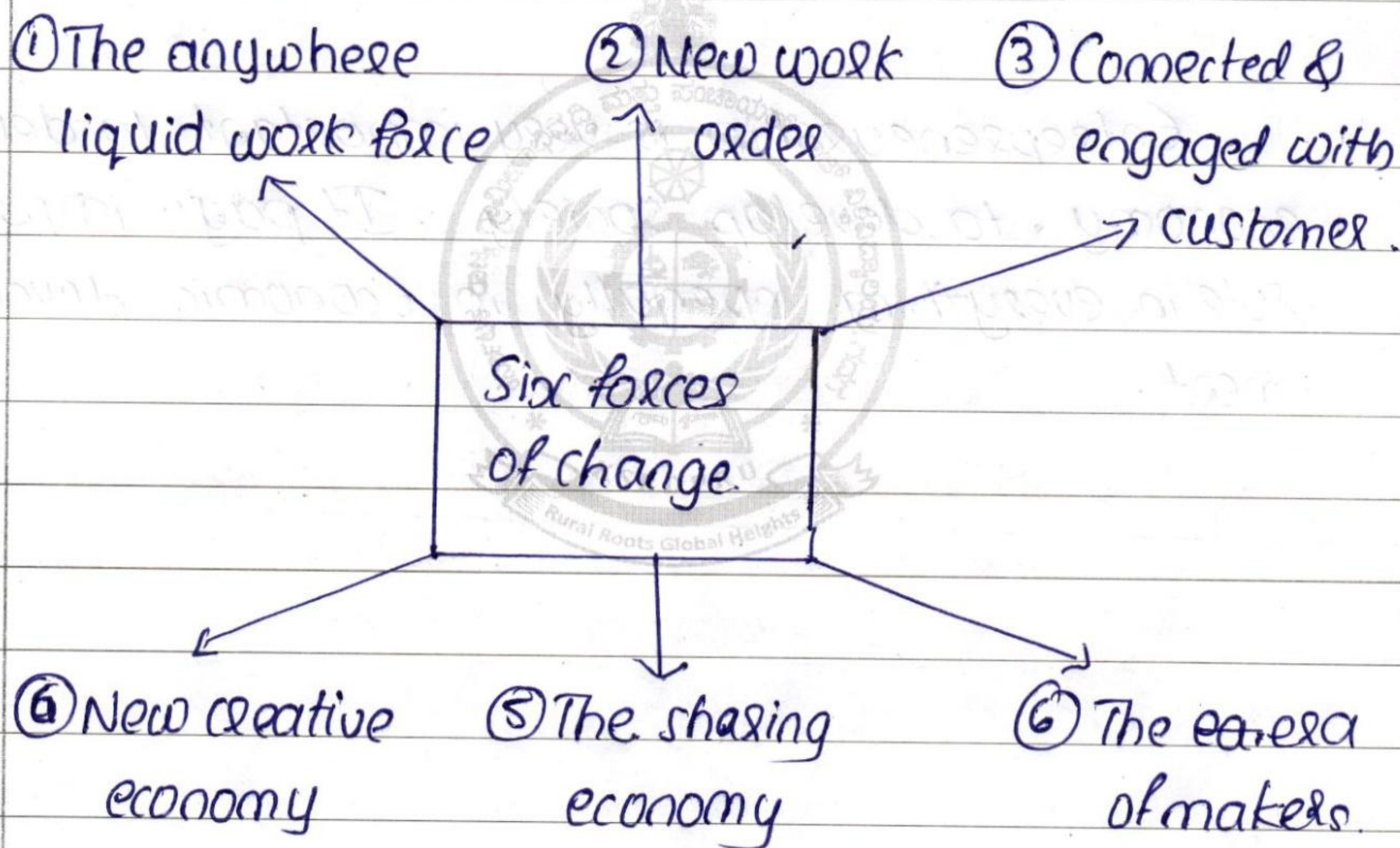

→ Entrepreneurs make some commitments in the business. Such as: Increasing sales, maximizing profits, sustaining in the business, Building strong foundation etc.

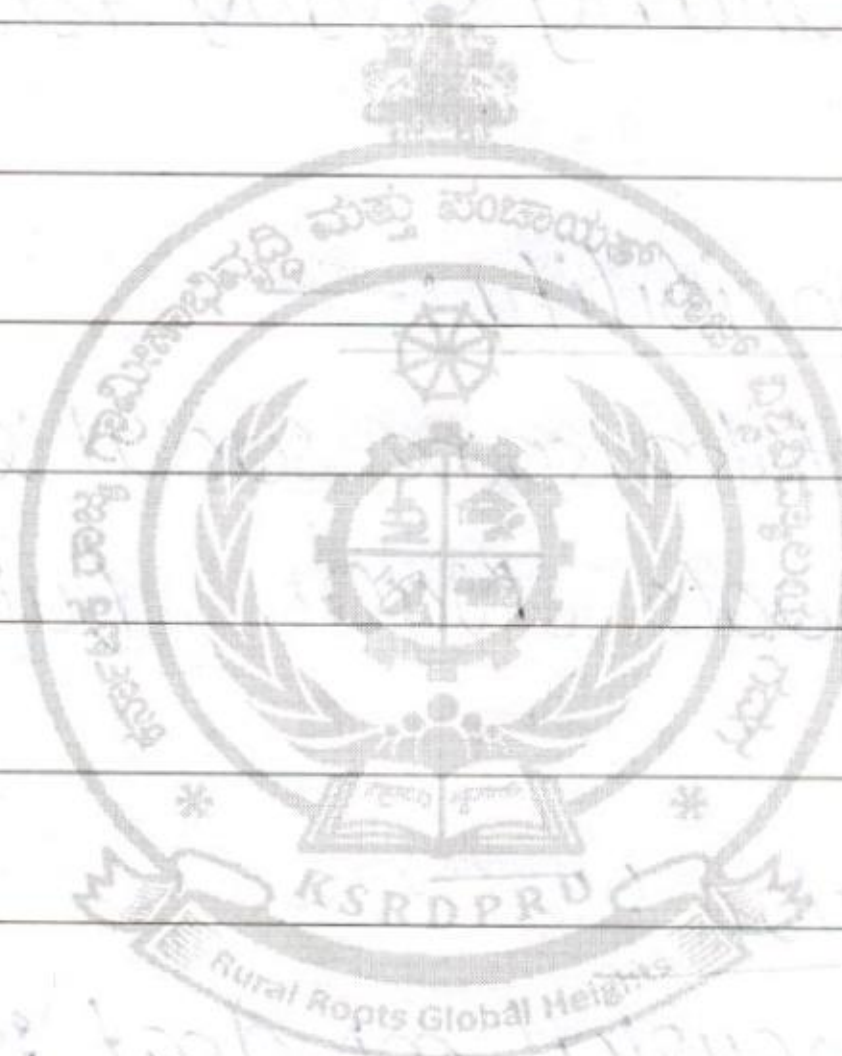
